## Parliament Updates:

- Committee for Justice in Palestine Spring '13 RECAP: At the end of Spring Qtr. at SUA a resolution came to the floor demanding the UC System stop funding companies students believed were supporting human rights violations in Israel. Parliament was asked to vote on this provocative document without sufficient time to research the facts. A vote was held at SUA and the resolution did not pass. The next Parliament meeting, members arrived to a letter on each of our chairs from a student rep. of CJP accusing Parliament of not fairly representing the students of Kresge. Parliament has now decided to send letter and invite the org. to attend a parliament meeting this year. Lucas will draft a letter and send out for a 48-hour review please respond with any comments.
- Deliberations Parliament reviewed how we will discuss funding requests. Points were
  made for discussion first then motion and motion first, discussion then second. After the
  meeting the Chair forwarded the verbiage from our constitution: Article V, Section VII reads
  in part: "Before a motion may be offered unanimous consent from Parliament, conclusion
  of the general discussion must be reached." The Constitution Update Committee can
  look at this as they rewrite out guiding document.
- Discussion also included the need for more thoughtful deliberations without the rush to get in the minutes as the person who motioned and/or 2nds.
- Parliament will also possibly introduce categorical spending caps for Student Media requests. Giving directions for max funding but leaving room for variations.
- The visit with CAO Mike Yamauchi-Gleason had to be cut short last week so he has let Parliament now he has available on Nov. 14<sup>th</sup> to come again = Kresge remodel planning
- Dining Services/Owl's Nest Manager Jeff Wildenboer had to cancel tonight's visit. Will reschedule soon.

IVC Max addressed the smoking ban as of 1/1/14 and J.N. acknowledged the special circumstance faced by UCSC

and our 2000-acre campus - possible designation of three smoking areas TBD. One student did leave the meeting upset over immigration issues. A Fossil Fuels divestment bill will come to the table at SUA soon as well as the Unity Campaign to create a pipeline to higher education for ex cons. We need a SOFA representative for SUA,
